

## DRAFT Minutes of the Annual General Meeting of Hambleton Parish Council (AGM) THURSDAY 9<sup>TH</sup> MAY, 7PM at Hambleton Village Hall

### 16/24 To carry out the Election of Chair and Declaration of Acceptance of Office

Cllrs Jeff Bramley nominated himself and this was seconded by Cllr Jenny Bramley. Cllr Maria Ferris nominated herself and this was seconded by Cllr Rossiter. With 2 candidates for the position, a vote was held. Cllr Jeff Bramley received 2 votes. Cllr Ferris received 4. One councillor abstained. **Resolved:** Councillor Ferris was elected chair and signed the Declaration of Acceptance of Office.

#### 17/24 Present and Apologies

#### 18/24 Election of Vice Chair and Declaration of Acceptance of Office

Councillor Rossiter nominated himself and this was seconded by Cllr Ferris. **Resolved:** Votes 4 (Bramley) to 3 (Rossiter). Councillor Bramley signed the Declaration of Acceptance of Office.

#### 20/24 Chair's address
